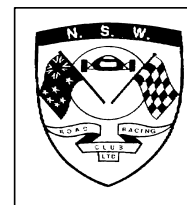

For Competitors - I/We being the competitor/s of the vehicle described on this Entry Form wish to enter that vehicle in the above event/s.
