



STANDARD SUPPLEMENTARY REGULATIONS FOR CLUB, MULTI CLUB AND THE 2010 CAMS NSW SUPERSPRINT CHAMPIONSHIP ROUNDS

1. **Authority:** This Event is held under the FIA International Sporting Code (ISC), the CAMS National Competition Rules (NCR) and Standing Regulations for Speed Events, these Supplementary Regulations, and any further regulations issued by the organising club. This Event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at www.cams.com.au.

9. Event Format

i) Cars will be divided into five (5) colour groups based on previous lap times recorded at the same circuit in the same vehicle. In the event that an driver has not competed at the track before, he/she will be placed in the "First Timers" group to determine their appropriate colour group, or if times are available from another circuit on the table below, then they may be placed in a group relative to those lap times.

The following colour groups will be used (refer table below for splits) and groups sent out in the order below:

a) Orange – Open Wheelers and Clubman-style cars

ii) As per attachment marked "Event Format"

Cars will be started in pairs, the number of pairs **as per the track capacity** shown for the circuit in the Supersprint Guidelines. Please specify number of pairs – 6 pairs or Red and Green, 8 pairs of all other groups

Each run will comprise **a minimum of 3 flying timed laps**, with the time for the fastest single lap being used for results. Please specify number of proposed laps - **3**

Proposed **minimum number of runs on the day** (please specify) - **6**

(Note: The Event will not be concluded when this minimum is achieved. Event will only be concluded early for safety reasons or if no competitors available)

Note: Grouping of pairs of cars to form a 'mini-race' anywhere on the circuit is NOT permitted, and action will be taken by the Clerk of the Course if such an incident takes place.

10. Familiarisation Session.

Three familiarisation laps behind a pace car will be given to drivers that have not previously competed at the track. They may be accompanied by a L2S Licence holder or higher with a minimum of 3 years experience as a passenger to assist in pointing out flag points, braking markers, racing lines etc.

11. Entries.

- Maximum number of Driver entries for the Event: **110** Reserves: **10**
- Maximum number of Drivers per competitor 2. Dual entry of drivers in the red group (refer clause 9) will be at the discretion of the organising club.

- f) Closing Date **26/07/2010**
A late entry fee of **\$20** will apply for entries received after the closing date.
- g) A pit usage fee of **\$ 25** per garage will be levied by the circuit owners.
- h) Entries will be accepted in order of receipt and must be sent to the Event Secretary on a properly completed Entry Form, accompanied by the appropriate entry fee. Cheques or money orders are to be made payable to the Organising Club. Credit Card details are to be completed on the entry form.
- i) Entries from Drivers between 16 and 18 years of age must be counter-signed/consented by a parent or legal guardian on the official entry form.
- j) The Organisers reserve the right to refuse any entry without giving a reason in accordance with NCR 83.
- k) Number of venue admission tickets included in entry fee: **\$ N/A** (if applicable)
- l) Letter/email confirming acceptance of entries *will be sent to each competitor* (only for entries received more than 5 days before the event).
- m) If an competitor advises the event secretary that he/she is unable to attend the event, the following procedure regarding a refund applies: Before 5 days of the event – full entry fee less \$25 for administration.
- n) Any vehicle presented for scrutineering will for the purpose of the entry be deemed to have competed.

12. Minimum Licences:

Current CAMS Level 2S Licence and a current *club membership card of a CAMS-affiliated Car Club* are compulsory and must be produced on the day of the Event or entry will be denied.

13. Drivers Safety.

Drivers must wear:

(a) A helmet that complies with AS1698 or better and carries marking to that effect, or is otherwise approved by CAMS (see Schedule D Section 1 [Headgear] of the General Requirements for Cars and Drivers, in the current CAMS Manual of Motorsport). Helmets must be in good condition and must not have any perforations to the outer surface.

(b) Non-flammable clothing extending from neck to wrist to ankles, (apparel of nylon or similar material is forbidden). For State Championship Rounds the minimum acceptable is one piece overalls or Driving Suits. The onus will be on the competitor to prove that older overalls/suits still have fire-resistant properties and are not impregnated with oil or fuel.

(c) Shoes, which completely cover the feet, made entirely of leather or other flame-resistant materials. Shoes that contain any synthetic materials such as nylon are forbidden.

(d) In open cars goggles or a visor with a lens material other than glass (ie to AS1609- 1981) are mandatory as are leather or Nomex gloves which entirely cover the hands.

14. Vehicle Categories & Classes As per table below

Classes for Types 1-3

Type 4 3D Sports Sedans (as per the CAMS Manual) and all Type 1, 2, 3 or SV vehicles, including prototype or limited production vehicles, which uses racing "slicks".

Classes for Type 4

0-1600cc 1601-2000cc 2001-3000 3001-6000cc

Type 5 Open wheelers as defined under 1st Category Racing Cars (as per the CAMS Manual), & Sports 1300 Clubman type vehicles.

Classes for Type 5

Formula Vees 1200 & 1600, Formula Ford, All others under 1600cc, All others 1600cc and over.

Type SV Road registered kit cars (Lotus 7 Replicas, Cobras etc), Limited Compliance cars and modified road registered vehicles having modifications in excess of that allowed in Types 1 and 2. running on commercially available tyres.

Classes for Type SV

0-1600cc 1601-2000cc 2001-3000cc 3001cc and above.

Note: Rotary and forced induction engines are subject to capacity multipliers as follows:

Rotaries – multiply by 1.8

Forced Induction – multiply by 1.7

Forced Induction Rotaries – multiply by 3.06

Note: The Organisers may re-classify any vehicle if they believe it is not eligible for the class in which it has been entered.

15. Scrutineering Requirements.

- a) All vehicles are to be presented at scrutineering and must comply with Schedules A & B of the CAMS General Requirements for Automobiles (as specific in the CAMS Manual), including
 - A fire extinguisher to CAMS requirements and fitted within reach of the driver.
 - A blue triangle, 150mm on each side mounted to indicate the battery location.
 - A secondary method of securing the bonnet.
 - All forward facing glass lenses to be completely covered by a protective film.
 - All loose objects are to be removed from the car.
 - The battery is to be firmly clamped.
 - Vehicles that have been issued with a CAMS Log Book must present the Log Book at Registration and Scrutineering.
- b) Competition numbers are to be positioned on both sides of the vehicle, and must be of a contrasting colour to the surrounding bodywork. They must comply with the current CAMS regulations as to size etc
- c) Drivers and vehicles must be presented in a clean and tidy manner, completely ready for the track including the driver's apparel and helmet. Any tyre or component changes to the vehicle after scrutineering must be approved by the Chief Scrutineer before the vehicle is taken onto the track.
- d) Any vehicle found to be leaking oil or fluids whilst competing will be suspended from the event until the Chief Scrutineer / Clerk of Course is satisfied that action has been taken to rectify the leak.

- ii) mutually exclusive (ineligible to outright award winners)
- c) Other awards (at Organiser's discretion)

- 24 Authority of Officials.** Any Driver not following a reasonable instruction by an official during the Event may be excluded at the discretion of the Stewards of the Meeting.
- 25 Medical Facilities. (Please Detail)** 1 x ambulance + 1 x paramedic + 1 x RMT
- 26 Crash Rescue and Fire Fighting Facilities (Please Detail)**
Rescue truck, fire truck, and tilt tray suitably manned
- 27 Insurance.** Public risk insurance has been affected by the Organisers. Refer Appendix 1 of the current CAMS Manual.
- 28 Personal Accident Contribution** is affected by the purchase of a CAMS Level 2S Licence (or higher).
- 29 Protests.** Any protests must be made in accordance with Part XII of the NCR's.
- 30 Postponement/Abandonment/Cancellation.** The organisers reserve the right to postpone, abandon or cancel the Event in accordance with the NCR 59.
- 31 Use of Prohibited Substances.** During the event consumption of alcoholic beverages in the paddock, pits or any part of the competition venue under the control of the officials is expressly forbidden until the practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crew or officials may be randomly tested for alcohol by a CAMS Accredited Testing Officer (CATO) or other drugs at any time during the event.
- The CAMS Anti-Doping Policy**, as it appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the Anti-Doping Policy conflict, the Anti-Doping Policy will take precedence.
- 32. Refreshment Facilities available. (Please Detail)** Canteen opened in paddock area
- 33. Additions and/or Alterations.**
Any additions and/or alterations to these Supplementary Regulations will be notified to all Drivers in the Final Regulations or during the Drivers' Briefing.
